## SALES AGREEMENT & UNDERTAKING

- 1. Where as the vendor has agreed to sell and the purchaser has agreed to buy all that \_\_\_\_\_\_ Plots (s) or land in ROYAL GATE, Ilara Epe Lagos, Nigeria.
- 2. Purchaser who made complete payment shall have their plots within ROYALGATES ESTATE.
- 3. INSTALLMENT PAYMENT TERMS:
- \_43% 50% Initial deposit and spread the balance within equal monthly installment.
- 4. ANCILLARY FEES:
- a. Development/Infrastructure fee: The sum of N500,000 for 500sqm and N350,000 for 300sqm is required and payable per plot (subject to review) which is to be paid within (6) months, upon full payment of the land fees, this shall be paid before phsical allocation of the land.
- b. Survey and documentation fees: The sum of N400,000 for 500sqm and N250,000 for 300sqm is required and payable per plot (subject to review) which is to be paid within (6) months upon full payment of land fees. This shall be paid before physical allocation of the land.
