SALES AGREEMENT & UNDERTAKING

- 3. INSTALMENT PAYMENT TERMS:

- 4. ANCILLARY FEES;
- a. Developmental/Infrastructure fee, The sum of N350,000 for 500sqm and N250.000 for 300sqm is required and payable per plot (subject to review) which is to be paid within (6) months, upon full payment of the land fees, this shall be paid before physical allocation of the land.
